Others are infected with COVID-19 Visitors, staff or children come into contact with the Virus	Possible	Severe	Very High	<ul> <li>Staff are provided with cleaning agents, bins and gloves as well as procedures to follow on the correct way to clean and sanitise (See ACI Hygiene and Cleaning Policy).</li> <li>Enhanced Hygiene practices are implemented for staff, children and visitors such as:         <ul> <li>Frequent hand washing (Alcohol based hand sanitiser is a suitable alternative if used and stored safely around children).</li> <li>Staff avoid touching face, handshakes and other close physical contact.</li> <li>Tissues are disposed of appropriately.</li> <li>Coughs and sneezes covered with elbow</li> </ul> </li> <li>Alcohol based hand sanitiser is available at the service entry.</li> <li>Where possible touch points are reduced (such as leaving access doors open where possible).</li> <li>Children are provided with increased and daily hand washing and personal hygiene guidance.</li> </ul>

There is insufficient environmental cleaning Children do not implement increased Hygiene Practices	Possible	Severe	Risk Rating  Very High		<ul> <li>Increased Hygiene and cleaning Practices throughout the service with regular cleaning throughout the session of High touch surfaces (such as family sign in and out area) and daily cleaning of used equipment and resources.</li> <li>Service Coordinator is to ensure that there is robust control and routine cleaning of the environment on a daily basis including: <ul> <li>Frequently touched surfaces and objects such as doors, tables, benchtops, and toys, are cleaned and disinfected at a minimum after every session using appropriate detergent and disinfectant.</li> <li>That staff use gloves when cleaning and either wash hands OR use alcohol based hand sanitiser before and after wearing gloves.</li> <li>Personal items such as phones, glasses, keyboards etc are cleaned and disinfected frequently (e.g. with disinfectant wipes).</li> <li>Amenities including kitchens, common areas, toilets are cleaned frequently.</li> </ul> </li> <li>Coordinators are to ensure that all cleaning is recorded daily in the SIM (Service Instruction Manual).</li> <li>Handwashing facilities are kept clean, properly stocked and in good working order throughout the session.</li> <li>Management will keep staff informed of service procedures, actions to take and symptoms to be concerned about. Clear guidance is provided to ensure expectations are understood.</li> <li>Families and parents are encouraged not to enter the service and to sign kids in and out in the designated area.</li> <li>Physical distancing measures are implemented throughout the service, wherever possible. Coordinators and Staff are to work together to identify reasonable and practical social distancing measures at each service. Document this in Team Talks.</li> </ul>
