Exposure to toxic emissions, gas, fuels	<ul> <li>As per our Emergency Procedures Manual – 3.13 Toxic Emissions/Gas/Fuels/Chemicals and Flip Chart</li> </ul>			
or chemicals resulting in –				
# Headache	In the event of spill/leak of toxic chemical, vapour or gas, internally/externally –			
# Nausea	Call Fire & Rescue			
# Vomiting	Remove everyone from danger and clear immediate area.			
! Skin corrosion	<ul> <li>Notify Chief Warden and adjoining properties if appropriate.</li> </ul>			
	<ul> <li>Turn off electrical equipment – air conditioning and gas supply.</li> </ul>			
	Close all doors (do not lock).			
	Chief Warden to determine if Protect in Place or Evacuation is deemed necessary.			
	Nominate person to meet Fire and Rescue.			
	<ul> <li>As per our Emergency Procedures Manual – 3.2 Protect in Place</li> </ul>			
	Some situations, taking shelter within the building will be the safest option. Each situation should be assessed as it			
	presents itself.			
	<ul> <li>Protect in Place can be imposed by responding Emergency Services or immediately by the ECO until the arrival of Emergency Services.</li> </ul>			
	Consultation with the Chief Warden is of the utmost importance.			
	All Staff will need to be advised and kept informed of the situation.			
	<ul> <li>Communication with the Chief Warden and or Emergency Services is vital. SMS, Mobile phones or landlines should be considered.</li> </ul>
