# Needle Stick	<ul> <li>As per our Emergency Procedures Manual &amp; Flip Chart – 3.12 Medical Emergencies and Needle Stick &amp; Syringe Disposal (Manual only).</li> <li>Check for any life-threatening situations and control, if safe to do so.</li> <li>Educators are to be vigilant and direct children when walking and placing rubbish into bin.</li> <li>Syringes – Do not attempt to pick up with fingers. Do not attempt to recap or replace cover.</li> <li>Use hands free technique eg. Ezi Reach or kitchen tongs.</li> <li>Pick up from blunt end and place in sharps container or rigid, walled, wide mouth puncture resistant container.</li> <li>Notify Coordinator/Chief Warden.</li> <li>Commence First Aid, if trained and safe to do so.</li> </ul>
	<ul> <li>Notify Emergency Services.</li> <li>As per our Emergency Procedures Manual &amp; Flip Chart – 3.17 Robbery/Personal Threat</li> </ul>
	Keep still and do not make sudden moves.
	Do not use phone in perpetrator's presence.
	Obey perpetrator's instructions.
	Observe perpetrator's appearance.
	Allow perpetrator to leave but do not follow.
# Child protection issues	Educators are to ensure children do not engage in conversations with strangers.
Bite/mauling	Educator to keep children away from all animals even if they look friendly.
	<ul> <li>If animal poses a threat Educator is to get children behind the school gate and proceed to move away slowly.</li> </ul>
	<ul> <li>As per our Emergency Procedures Manual &amp; Flip Chart - 3.19 - Natural Disasters &amp; 3.20 External Emergencies</li> <li>In extreme weather conditions the children will not take the bin in/out.</li> </ul>
	<ul> <li>As per our Emergency Procedures Manual &amp; Flip Chart - 3.22 - Missing Child</li> <li>Search immediate area.</li> <li>Chief Warden to coordinate searchers and search area.</li> </ul>

	Notify parents
Risk -	As per ACI Policies, Education and Care Services National Regulations and Law
# Trips, slips & falls	<ul> <li>New Educators are orientated on procedures on walking children to take garbage and recycling materials out to skip bins.</li> </ul>
# Cuts/grazes	<ul> <li>Safety Rules are discussed with children, before taking the garbage and recycling out.</li> <li>Hazards – eliminated, sectioned off or totally avoided. Maintenance Log in (SIM) and ACI Hazard Report to be completed and forwarded to School Principal.</li> <li>Educators and children are to follow our Sun Protection Policy and Work Health and Safety Policy.</li> <li>Phones and Walkie Talkies to be charged for each Session.</li> <li>Educator will carry Centre Mobile Phone.</li> <li>First Aid Kit is not required to be taken on walk. Educator can communicate with Centre if First Aid Kit is required. Educator can contact Emergency Services if required.</li> <li>Educators to be on site are First Aid trained and First Aid Kits fully stocked.</li> </ul>
